If the court has no jurisdiction over the subject matter, the sentence, in a technical sense, is a mere nullity. It is what is technically termed a void sentence." Lisenba v. not only of the rule, but of what the violation of it has subjected the defendants to. It will also enable the government, if it prefer to try the case without a jury, to see to it, at the time the objection is made, that it is grounded upon some actual fact." Reynolds v.
